Dear Mr. Goebel:

The CNS NWMDER-2019 Conference has received a number of e-mails from you containing unprofessional remarks or language. I sincerely hope that such unwelcome e-mails will stop, otherwise we will have no choice other than to withdraw any invitation to you to attend NWMDER-2019.

You have also uploaded an Abstract (and an updated version) and a "Paper" on the conference submission site. However, the paper is simply a collection of graphics, and the updated Abstract is not what we consider to be in proper form, as it refers to 14,700 co-authors, which, to say the least, is an unacceptable inclusion. I must remind you that the Technical Paper (which will include an Abstract) must be on the official conference template. If the Final Paper, when submitted, does not comply with the CNS requirements, it will have to be rejected.

I send you best regards. I do hope that future communications will be on a more agreeable basis.
